The Government of Angola, through its Ministry of Health of Angola (MOH) has received financing from the World Bank toward the cost of the Regional Disease Surveillance Systems Enhancement Project (REDISSE IV), and intends to apply part of the proceeds toward the Procurement of: **Tests and reagents for priority diseases in Angola concerning human and animal Health, to support the Epidemiological and Laboratorial Surveillance.**
2. The Regional Disease Surveillance Systems Enhancement Project (REDISSE IV) now invites sealed Bids from eligible Bidders for the Procurement of:  
**LOT 1: Tests and Reagents for priority diseases in Angola concerning human health;**  
**LOT 2: Tests and reagents for priority diseases in Angola concerning animal health,**  
and **LOT 3: Tests and reagents concerning human health;** to be delivered using Incoterms - **Carriage and Insurance Paid (CIP)**, Final Destination (Project Site) is Luanda – Angola, the place of destination is: Instituto Nacional de Investigação em Saúde (INIS), Rua Amílcar Cabral nº 96, em frente ao Banco de Urgências do Hospital Josina Machel, na Maianga – Luanda. The delivery time is 90 days, after Contract adjudication.
